MARGINS

A4 Paper Size: Top = Bottom =1"; Left = Right=1"; Header= Footer =0.5"; Single Column; Line Spacing: 1.5; First line Indentation: 0.14; Hanging Indents: 0.36; font size 10; Justified Alignment. Reference Font size: 8; Author's profile Font size: 8

Note:

Do not insert any footnote or end note, if it's required in your paper then please move to reference section.

Do not insert anything in header / footer.

Avoid any abbreviation / symbol in paper title.

Timeline Publication

1. Page Layout

Your paper must use a page size corresponding to A4 which is 210 mm (8.27") wide and 297 mm (11.69") long.

The margins must be set as follows:

- Top = Bottom =1"
- Left = Right=1"
- Header= Footer =0.5"

Use **single column**, do not use two-column format.

1. Paper Size must be A4 (8.27" x 11.69").

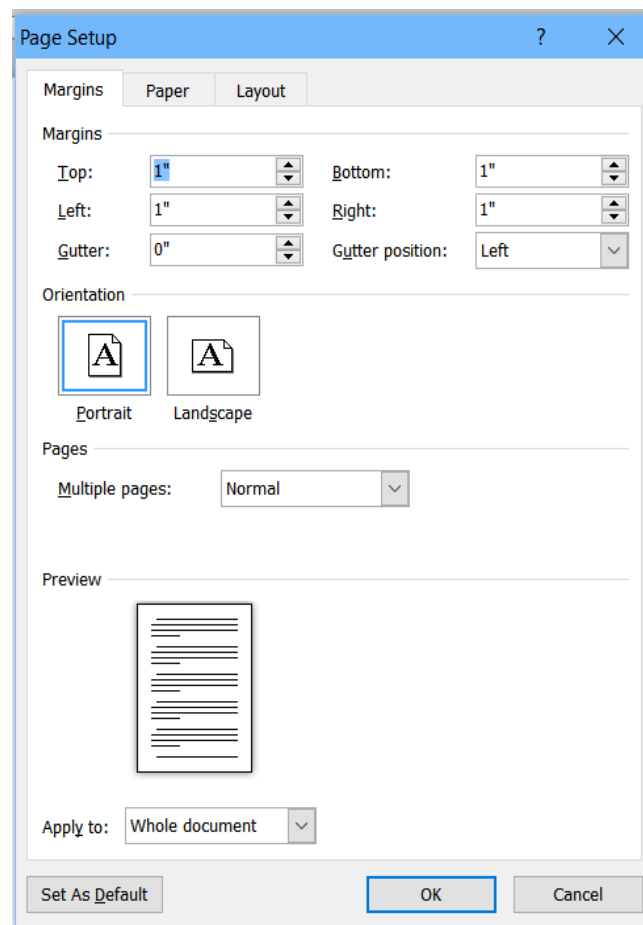

2. All fonts name must be Times New Roman.
3. Title of the paper font: size 20, bold and centre.
4. Authors name font: size 11, bold and centre aligned.
5. Font size of the Abstract and Index Term (Keyword) must be 9 with bold. Word "Abstract" should be written as "Abstract-" (i.e. Bold and italic) and rest should be only italic.
6. All Main Heading must be in (SMALL CAPS) font size 12, BOLD, line space as per font size paragraph i.e. 10 point, and Line Spacing must (1.5). For this right, select the matter which not contain image or table, and go to paragraph and maintain as per norms (Fig. 2).

Timeline Publication

For **SMALL CAPS** style, type the matter as per given instruction:

- I. First character of the word(s) must be **CAPITAL**
 - II. Rest character of the word(s) must be **small**
 - III. Select the word(s)
 - IV. Press Ctrl + Shift + k (output will be as **SMALL CAPS**)
7. All Sub Heading must be in Sentence Case, font size 11 and style *Italic* and Line Spacing must be (1.5). For this right, select the matter which not contain image or table, and go to paragraph and maintain as per norms.
8. Matter of paragraph :
- I. First line indentation must be 0.14, line spacing 1.5, font size 10, justified alignment. Hanging indents 0.36.

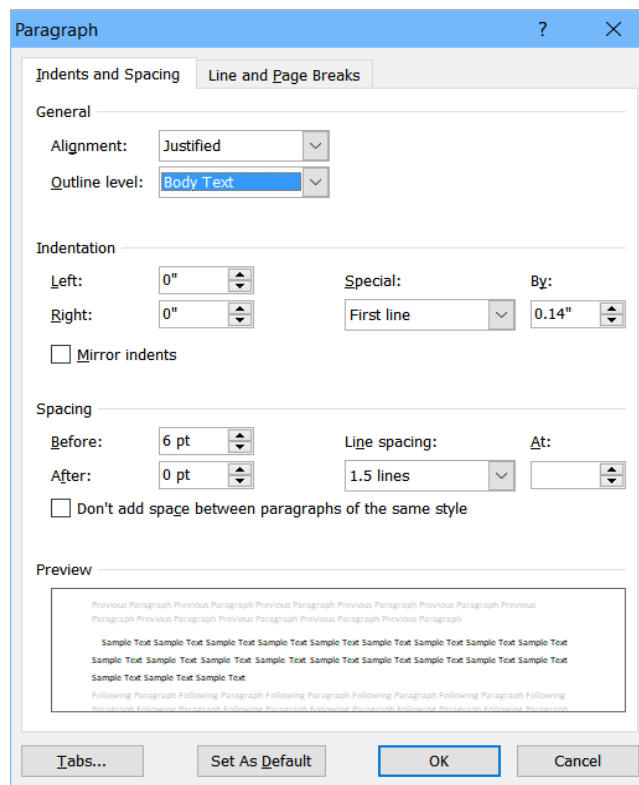

10. Font size for Author's profile: 8.
